Contract Terms and Conditions

1. While the stud undertakes to take due care with The Mare, Dingmac Stud accepts no responsibility for any injury etc. that may occur to The Mare while it is in the care of Dingmac Stud.
2. Dingmac Stud makes no guarantee that The Mare will conceive after being served by The Stallion. In the event that The Mare fails to conceive another Mare may be offered a service at the discretion of Dingmac Stud.
3. Where Dingmac Stud deems necessary a veterinary surgeon may be called to The Mare. Dingmac Stud will make every attempt to contact The Owner prior to calling the veterinary surgeon subject to the Stud's opinion of The Mare's welfare being paramount. Any and all associated costs are the responsibility of The Mare owner and fall due on billing.
4. The Mare owner undertakes to make payment of all monies due under this agreement on the due date. The due date is on uplift of The Mare. A breed society covering certificate will not be issued until all monies due are paid.
5. The Mare owner grants to Dingmac Stud a lien over the mare and pregnancy in respect of moneys due under this agreement. Dingmac Stud shall have the power to sell the mare and or progeny over which such a lien is taken to recover moneys, including interest, and for the purpose of exercising power of sale, the owner irrevocably appoints the stud as its attorney to do all acts, including exercising the power to sell the mare and or progeny, to recover the moneys together with all costs and expenses incurred by the stud in exercising the power of sale arising from the default of The Mare owner pursuant to the agreement.
6. The Mare Owner must ensure that The Mare is in good health (e.g. not overweight), has trimmed feet and has been wormed immediately prior to the arrival at Dingmac Stud. Hind shoes must be removed. Worming and feet trimming carried out by the stud (usually 6-8 weeks) will be charged at the actual cost inclusive of GST and be billed to the Mare owner.
7. The daily agistment fee covers keep at grass. Mineral blocks are provided. Any additional feed to be provided by the mare's owner.
8. Dingmac Stud prefers to run mares with the stallion to provide as natural service as possible. In situations when in hand covering is required (for example where the size of the mare dictates) an additional handling fee is required.
9. Dingmac Stud reserves the right to not serve any Mare which in their opinion is an unreasonable danger to handlers or stallion. In such a situation the agistment fee will remain payable.
10. A 48hr live foal guarantee applies. If the mare is found to be not in foal or the foal dies within the first 48hrs of birth, The Mare may be returned for one free service cycle - any more are at Dingmac Stud's discretion. There will be no refund of service fee. Scanning is recommended to confirm pregnancy. In the event of the death of the foal within 48hrs of birth a vet's certificate will be required. It is the owner's responsibility to insure the life of The Mare. Dingmac Stud has no responsibility in the event of The Mare's death during pregnancy or labour.
